NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Texas 77056, said address being an office and meeting place of the District.

The meeting will be held on *Tuesday, September 13, 2016, at 12:00 noon.*

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and approval of the minutes of the August 9, 2016, Board of Directors meeting;
2. Public Comments;
3. Tax Assessor-Collector's report, including authorizing the payment of invoices presented, approving tax refunds, and approving the moving of accounts to the uncollectible roll;
4. Receive the Financial Advisor's recommendation concerning the District's proposed 2016 tax rate, determine intended tax rate, and authorize:
 - a) The required notice that the Board will consider adoption of a tax rate; and
 - b) The means of providing such notice;
5. Report on legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claims;
6. Operator's report, including:
 - a) Monthly report;
 - b) Appeals of District charges, refer accounts for collection, approve write-off of uncollectible accounts and review of any customer complaints; and
 - c) Hurricane preparedness;
7. Engineer's Report, including:
 - a) Authorize the design and/or advertisement for bids for the construction of facilities within the District and approving of related storm water plans, including:

- 1) Review and approval of any Storm Water Pollution Prevention Plans related to construction within or on behalf of District, and the execution of any documentation in connection therewith;
 - 2) Status of Storm Water Management Plan; and
 - 3) Status of 2017 Lift Station Rehabilitation Project;
- b) Authorize the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and approval of any related storm water permits;
 - c) Status of construction of facilities to serve land within the District, and the approval of any pay estimates and change orders, including;
 - 1) Status of the construction of crosswalk relative to park facilities by Traffic Systems Construction;
 - d) Discussion regarding proposed turn lane at County Road 94 and Southfork Drive and County traffic study regarding same;
 - e) Status of Capital Improvement Plan; and
 - f) Status of amendment of Restated Joint Water Facilities Contract by and among the District, Brazoria County Municipal Utility District No. 2, Brazoria County Municipal Utility District No. 3, and the City of Pearland;
8. Adopt Resolution Authorizing Use of Surplus Construction Funds and Interest Earned on Construction Funds relative to (i) 2017 Lift Station Rehabilitation Project and (ii) Water Plant Improvement Project;
 9. Park report;
 10. District's website;
 11. Requests for utility commitments;
 12. Developers' reports;
 13. Bookkeeper's report;
 14. Attorney's report, including status of Silverlake Shopping Center drainage easements and conveyances;
 15. Discussion regarding special meeting within the District to discuss the possible construction of a dog park at Sasser Park;

16. Matters for possible placement on future agendas.
