NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Texas 77056, said address being an office and meeting place of the District.

The meeting will be held on *Tuesday, January 10, 2017, at 12:00 noon.*

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:


1. Review and approval of the minutes of December 5, 2016, and December 13, 2016, Board of Directors meetings;
2. Public Comments;
3. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented, approving tax refunds, and approving the moving of accounts to the uncollectible roll;
4. Report on legal action taken by the District's delinquent tax collections attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claims;
5. Grant exemptions from taxation for 2017, and the adoption of a Resolution in connection therewith;
6. Adoption of Resolution Authorizing an Additional Penalty on Delinquent Personal Property Taxes and authorize delinquent tax attorney to collect delinquent personal property taxes beginning April 1, 2017, including the filing of lawsuits, as necessary;
7. Operations Report, including:
 - a) Monthly report;
 - b) Appeals of District charges, refer accounts for collection, approve write-off of uncollectible accounts and review of any customer complaints; and
 - c) Authorize operator to provide required information to districts receiving water from the District relative to Consumer Confidence Reports;

8. Engineering Report, including:
 - a) Authorize the design and/or advertisement for bids for the construction of facilities within the District and approving of related storm water plans, including:
 - 1) Review and approval of any Storm Water Pollution Prevention Plans related to construction within or on behalf of District, and the execution of any documentation in connection therewith;
 - 2) Status of Storm Water Management Plan;
 - 3) Status of 2017 Lift Station Nos. 2, 3 & 5 Rehabilitation and Improvements Project; and
 - 4) Status of 2017 Water Plant Improvements Project;
 - b) Authorize the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and approval of any related storm water permits;
 - c) Status of construction of facilities to serve land within the District, and the approval of any pay estimates and change orders;
 - d) Status of Capital Improvement Plan; and
 - e) Status of amendment of Restated Joint Water Facilities Contract by and among the District, Brazoria County Municipal Utility District No. 2, Brazoria County Municipal Utility District No. 3, and the City of Pearland;
9. Approve preparation and filing of Amended District Registration Form;
10. Discussion of renewal of District insurance coverages and authorize solicitation of proposals for same;
11. Park Report;
12. District's website;
13. Requests for utility commitments;
14. Developers' Reports;
15. Bookkeeper's Report;
16. Adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;

17. Attorney's Report;
18. Discussion regarding social media policy of the District; take any action necessary in connection therewith; and
19. Matters for possible placement on future agendas.
